This website ("Our Site") uses Cookies and similar technologies in order to distinguish you from other users. By using Cookies, We are able to provide you with a better experience and to improve Our Site by better understanding how you use it. Please read this Cookie Policy carefully and ensure that you understand it. Your acceptance of Our Cookie Policy is deemed to occur if you continue using Our Site. If you do not agree to Our Cookie Policy, please stop using Our Site immediately.

2. Information About Us

Our Site is owned and operated by Roast & Ground Limited, a limited company registered in England under company number 04523314, whose registered address and main trading address is Unit 6 Kingston Business Centre, Fullers Way South, Chessington, KT9 1DQ.

3. How Does Our Site Use Cookies?

Our Site may place and access certain first party Cookies on your computer or device. First party Cookies are those placed directly by Us and are used only by Us. We use Cookies to facilitate and improve your experience of Our Site and to provide and improve Our products and/or services. We have carefully chosen these Cookies and have taken steps to ensure that your privacy and personal data is protected and respected at all times.

By using Our Site, you may also receive certain third-party Cookies on your computer or device. Third party Cookies are those placed by websites, services, and/or parties other than Us. Third party Cookies are used on Our Site for functional purposes. For more details, please refer to section 4 below

All Cookies used by and on Our Site are used in accordance with current Cookie Law. We may use some or all of the following types of Cookie:

(i) Essential Website Cookies

These cookies are strictly necessary to provide you with services available through our websites and are necessary for our website to function properly. Because these cookies are essential to operate our websites, you are unable to opt out of these cookies.

(ii) Analytics Cookies

These cookies collect information that is used either, in aggregate form to help us understand how our websites are being used, provide information on how effective our marketing campaigns are, or to help us customize our websites for you.

(iii) Functionality Cookies

Functionality Cookies enable Us to provide additional functions to you on Our Site such as personalization and remembering your saved preferences. Some functionality Cookies may also be strictly necessary Cookies, but not all necessarily fall into that category.

(iv) Targeting Cookies

It is important for Us to know when and how often you visit Our Site, and which parts of it you have used (including which pages you have visited and which links you have visited). As with analytics Cookies, this information helps us to better understand you and, in turn, to make Our Site and advertising more relevant to your interests. Some information gathered by targeting Cookies may also be shared with third parties.

(v) Third Party Cookies

Third party Cookies are not placed by Us; instead, they are placed by third parties that

(vi) Persistent Cookies

Any of the above types of Cookie may be a persistent Cookie. Persistent Cookies are those which remain on your computer or device for a predetermined period and are activated each time you visit Our Site.

(vii) Session Cookies

Any of the above types of Cookie may be a session Cookie. Session Cookies are temporary and only remain on your computer or device from the point at which you visit Our Site until you close your browser. Session Cookies are deleted when you close your browser.

Cookies on Our Site are not permanent and will expire in the timescales set out below.

HubSpot sets a number of cookies when a visitor lands on our website. We use cookies for several reasons. Some cookies are required for technical reasons in order for our websites to operate properly, others enable us to perform analytics, provide different functionality or engage in targeted marketing. Essential/necessary cookies

These are essential cookies that do not require consent.

__cfruid

This cookie is set by HubSpot's CDN provider because of their rate limiting policies. It expires



at the end of the session. Learn more about Cloudflare cookies.
cfuvid
This cookie is set by HubSpot's CDN provider because of their rate limiting policies. It expires at the end of the session. Learn more about Cloudflare cookies.
cf_bm
This cookie is set by HubSpot's CDN provider and is a necessary cookie for bot protection. It expires in 30 minutes. Learn more about Cloudflare cookies.
hs_opt_out
This cookie is used by the opt-in privacy policy to remember not to ask the visitor to accept cookies again. This cookie is set when you give visitors the choice to opt out of cookies. It contains the string "yes" or "no". It expires in 6 months.
hs_do_not_track
This cookie can be set to prevent the tracking code from sending any information to HubSpot. It contains the string "yes". It expires in 6 months.
hs_initial_opt_in
This cookie is used to prevent the banner from always displaying when visitors are browsing in strict mode. It contains the string "yes" or "no". It expires in seven days.
hs_cookie_cat_pref
This cookie is used to record the categories a visitor consented to. It contains data on the consented categories. It expires in 6 months.
hs_gpc_banner_dismiss
This cookie is used when the Global Privacy Control banner is dismissed. It contains the string "yes" or "no". It expires in 180 days.
hs_notify_banner_dismiss
This cookie is used when the website uses a Notify consent banner type. It contains a boolean value of True. It expires in 180 days.
hs_ab_test
This cookie is used to consistently serve visitors the same version of an A/B test page they'version before. It contains the id of the A/B test page and the id of the variation that was

e chosen for the visitor. It expires at the end of the session.

<u>hs-messages-is-open</u>

This cookie is used to determine and save whether the chat widget is open for future visits. It is set in your visitor's browser when they start a new chat, and resets to re-close the widget after 30 minutes of inactivity. If your visitor manually closes the chat widget, it will prevent the widget from re-opening on subsequent page loads in that browser session for 30 minutes. It contains a boolean value of True if present. It expires in 30 minutes.



hs-messages-hide-welcome-message

This cookie is used to prevent the chat widget welcome message from appearing again for one day after it is dismissed. It contains a boolean value of True or False. It expires in one day.

hsmem

This cookie is set when visitors log in to a HubSpot-hosted site. It contains encrypted data that identifies the membership user when they are currently logged in. It expires in seven days.

hs-membership-csrf

This cookie is used to ensure that content membership logins cannot be forged. It contains a random string of letters and numbers used to verify that a membership login is authentic. It expires at the end of the session.

hs.superstore.laboratory.

It contains an offline cache of cohorts that a user got assigned for HubSpot Product experiments. It doesn't contain personal identifiable information or information that can identify your device or hardware HubSpot experiments are anonymous and aren't attached to user sessions. However, if tracking consent is given, specific experiments might be tied to identifiable user sessions. The individual contents of this storage entry expire automatically upon specific dates determined by HubSpot Product. Often, these are 48 hours. It can't be manually removed and is automatically created whenever conditions are met.

<id> key

When visiting a password-protected page, this cookie is set so future visits to the page from the same browser do not require login again. The cookie name is unique for each password-protected page. It contains an encrypted version of the password so future visits to the page will not require the password again. It expires in 14 days.

Analytical cookies

These are non-essential cookies controlled by the cookie banner. If you're a visitor to a site supported by HubSpot, you can opt out of these cookies by not giving consent.

__hmpl and hublytics_events_53

This browser storage entry is used by HubSpot Product to temporarily store tracking events created by HubSpot Product until they get dispatched over the network. It's stored either on the Browser's Session Storage or Local Storage based on the presence or lack of tracking consent. When tracking consent isn't given, this cookie stays within the current browser session and expires at the end of the session. This "cookie" will remain empty and not store anything. It contains metadata regarding tracking events that HubSpot collects throughout the user's journey at HubSpot. The main cookie for tracking visitors. It contains the domain, hubspotutk, initial timestamp (first visit), last timestamp (last visit), current timestamp (this visit), and session number (increments for each subsequent session). It expires in 6 months.

hubspotutk

This cookie keeps track of a visitor's identity. It is passed to HubSpot on form submission and used when deduplicating contacts. It contains an opaque GUID to represent the current visitor. It expires in 6 months.

This cookie keeps track of sessions. This is used to determine if HubSpot should increment the session number and timestamps in the

hstc cookie.

It contains the domain, view Count (increments each page View in a session), and session start timestamp. It expires in 30 minutes.

hssrc

Whenever HubSpot changes the session cookie, this cookie is also set to determine if the visitor has restarted their browser. If this cookie does not exist when HubSpot manages cookies, it is considered a new session. It contains the value "1" when present. It expires at the end of the session.

Platform and Payment Cookies (OpenCart and Stripe) (www.shop.roastandground.co.uk)

Our Roast & Ground online shop uses the **OpenCart** platform for e-commerce and **Stripe** as our secure payment gateway. Both systems set cookies on your device to ensure smooth functionality, security, and an optimal shopping experience. These cookies are essential for operations such as browsing, shopping cart management, language and currency selection, and payment processing.

Google Cookies

Utma

This is the main way Google Analytics tracks unique visitors. Stored in this cookie is a unique visitor ID, the date and time of their first visit, the time their current visit started and the total number of visits they have made. The __utma cookie is a persistent cookie that expires in two years. With each new visit, the expiration date is refreshed.

utmb

This is how Google Analytics decides whether a visit has timed out and also how deep a visit has gotten. It stores the number of pageviews in the current visit and the start time of the visitor's current visit. The __utmb cookie is a persistent cookie that expires in 30 minutes. Each pageview refreshes it.

__utmc

The __utmc cookie is the only session cookie used by Google Analytics. Its only purpose is to register that the visit ended if the browser gets closed.



utmz

This is the traffic source cookie. It contains all of the traffic source information for the current visit, if it was different from the previous visit. If no traffic source information can be found for the current visit, the cookie is not changed. This is the way that Google Analytics attributes visit information, including conversions and transactions to a traffic source. It does not contain historical information for previous sources. This is a persistent

cookie with a catch: it expires in six months and is only refreshed when the traffic source changes. Every other cookie is refreshed with each pageview. The impact of this is that a banner ad that brings a visitor to your site will get the credit for all future direct visits for up to six months. After six months, if there have not been visits from any other source, the cookie will expire and start to attribute information to direct visits.

__utmv

This is the user-defined variable cookie. Developers can segment visitors by custom variables by calling a native JavaScript method. This new variable gets stored in a persistent cookie which expires in two years.

5. Consent and Control

When you visit Our Site cookies may be placed on your computer or device. By visiting Our Site you are giving your consent to the placing of Cookies and you are enabling Us to provide the best possible experience and service to you.

In addition to the controls that We provide, you can choose to enable or disable Cookies in your internet browser.
